4.3 The Club held a successful Question Time Debate last year after the AGM which was highly successful and ICE has now taken this up to make it a regular event. This year's hybrid event after this AGM meeting was over-subscribed.

4.4 The Chair thanked the committee for their hard work in ensuring the successful day to day running of the Club. Much was being done by a few members and we need younger members to join the committee to spread the load. This included finding a new Chair.

4.5 The Chair's report was accepted unanimously.

5.1 Peter Richardson thanked the Chair Balmforth for all his work for the Club in the past year, together with all Committee Members for their cheerful devotion to their duties.
